1) Updates on HoCare Project - Actions taken

Panayiotis Mountoukos, HoCare Financial Manager, did a brief presentation on the HoCare Project Updates and informed the attendees about the successful completion of the A' Phase of the project.

2) Presentation of the Action Plan prepared by Nicosia Development Agency

Eleni Malekkidou, HoCare Communication Manager, presented the **Action Plan prepared by Nicosia Development Agency.** The **Action Plan** includes all necessary information on how the lessons learnt from the cooperation will be exploited in order to improve the policy instrument tackled in Cyprus. The presentation contained the nature of the actions that have already been implemented such as:

the project fiche that has been prepared and submitted for approval by the e-Government Committee of Cyprus)

And are to be implemented, such as:

- A technical document that will be prepared and submitted to the MA for including the new project under financing through the selected PI (oral confirmation already granted in the presence of the President of Cyprus)
- A study visit in Slovenia is proposed to take place in order to analyze in detail the technical specificities of the GP and then to adopt in local environment accordingly.

The second part of the presentation was focused on the Project Implementation plan that contains the timeframe; the players involved; the costs and; funding sources.

The attendees have been informed about the project fiche that has been prepared and submitted for approval by the e-Government Committee of Cyprus.
