The participating experts represented the whole Quadruple Helix (QH): patients' and professionals' or formal and informal care providers' organizations as **END-USERS**; ICT, MEDTECH, cluster and industrial park associations and organizations as **BUSINESS**; universities and researchers as **ACADEMIA**; and authorities for HTA, licencing, policy making and financing/granting or development programmes as **PUBLIC**.

Stakeholders were informed by NHSC (ÁEEK) about the work resulting 3 Thematic Studies and 3 Policy Transfer Reports, and got brief information about the country specific conclusions and recommendations of these documents.

Participants of the RMG meeting discussed **KEY CHALLENGES** detected by the studies and reports concerning following topics:

1. Innovation in home care to satisfy unmet needs:

- innovation ecosystem formal and informal healthcare providers inside of the innovation ecosystem and the transfer of knowledge of unmet needs;
- support from operational programme support of formal and informal healthcare providers inside the research and innovation projects in the operational programme.

2. Public driven innovation in home care:

- innovation ecosystem public organizations as ppi, pcp and other innovative projects initiators,
- support from operational programme support of public driven innovation programmes / initiatives from operational programme.

3. Bringing results of innovation faster to home care market:

- innovation ecosystem quadruple helix cooperation to boost homecare solutions faster to the market:
- support from operational programme support of market successful innovation developed by quadruple helix cooperation inside the research and innovation projects in the operational programme.

The RMG members discussed the **Good Practices** provided by HoCare project partners and agreed to concentrate on examining the possibilities and opportunities of transferring the following GPs:

- 1. GPs about the driving function of end-users' unmet needs, which may be interesting to transfer:
 - the way of cooperation (learnings and elements of the following 2 GPs might be transferred jointly in one lot):
 - InTraMed-C2C (CZ)
 - GRACE (PT);
 - the **result o**f cooperation (learnings and elements of the following 2 GPs might be transferred jointly in one lot):

- Tele-Rehabilitation (CY)
- RehabNet (PT).

- 2. GPs about public driven innovation, which may be interesting to transfer:
 - the way of cooperation (learnings and elements of the following 2 GPs might be transferred jointly in one lot):
 - Codification of projects' evaluation targeting societal challenges including Health, Demographic changes and Well-being (PT)
 - Evaluation bonus for addressing horizontal priority "Health for all" (LIT)
 - the **result of** cooperation (learnings and elements of the following 2 GPs might be transferred jointly in one lot):
 - Tele-hippocrates (CY)
 - Check Point Cardio (BG)
- 3. GPs about putting innovation faster to market, which may be interesting to transfer:
 - the way of cooperation:
 - EkoSMART (SLO)
 - the **result of** cooperation:
 - Psiprof (PT)

NHSC (ÁEEK) informed participants of the meeting about the directions to define the focal points for the **recommendations** of the Regional Action Plan. RMG members discussed these ideas and provided **details and confirmation for ÁEEK to finalize** the drafts of the Policy Transfer Reports **and start** developing and drafting the Regional Action Plan (that would be finalized through 1-2 additional RMG meetings and MA discussions latest by the end of March 2018.

The RMG agreed with the **general conclusions**, **specific comments**, **overall recommendations** and **action-** or **call-level proposals** regarding Economic Development and Innovation Operational Programme (EDIOP/GINOP).
