


Call for additional activities in 2021



- New opportunities to face and recover from the COVID-19 crisis
- Open to 258 approved projects (but primarily relevant to 1st and 2nd call projects);
- Focus on exchange of experience activities and pilot actions if justified
- Monitoring Committee final decision expected in March.

- December 2019: start of the programming process

Key features remain:

- 1. Pan-European
- 2. Similar overall objective
 - Regional policy makers as core target groups
- 3. Similar means to achieve the objective
 - Main focus on capacity building
- 1. Focus on Structural Funds lightened
- 2. Learning by doing: pilot actions
- 3. Only one single priority in the programme
 - Better reflect the core nature of the programme (capacity building)
