Translation, Innovation and Technology Transfer in Ageing Network

TITTAN PROJECT IS ALREADY UP AND RUNNING!



Active and Healthy Ageing are a common challenge through Europe, and within TITTAN, the partners involved have come together to improve the quality and performance of their Regional Health Care Systems through knowledge exchange and innovation.

The project is funded by the Europe Territorial Cooperation Program, selected in a very competitive call. TITTAN consortium shares good practices to promote three different thematic areas:

- Innovation from the companies to the health services (outside-in).
- Transfer of technology from the health services to the patients.
- Active involvement of citizens in the management of ageing and health.

The Kick-off meeting took place on the 30th of May in Amsterdam with the objective to launch, coordinate and plan the project activities. Each region worked during the first semester on the development of a Regional Assessment Plan which is the base for exchange of best practices between the areas. 52 good practices were identified in total, 15 good practices related to the Thematic Area 1, 16 good practices related to the Thematic Area 2 and 21 good practices related to Thematic Area 3.

This very successful report will inform the series of workshops and also the development of each regions Action Plans.

FIRST INTERREGIONAL WORKSHOP OUTSIDE-IN INNOVATION

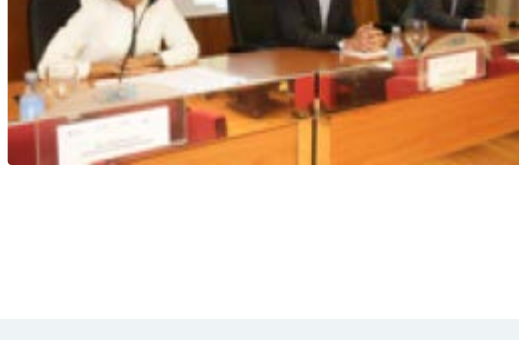
Santiago de Compostela, 5-7 September 2016

The 5th of September, Jesús Vázquez Almuíña, the Galician Ministry of Health, welcomed the TITTAN Team to the First Interregional Workshop which took place in Santiago de Compostela.

This first workshop was focused on facilitating the transfer of existing knowledge and technological developments in the private sector towards health systems. Experts shared innovation programs and initiatives between the public and private sector that have been successfully implemented in their respective regions by making a clear benefit to patients and health systems. Particular emphasis was put on promoting methodologies of Innovative Public Procurement.

After the Workshop, the Action Group 1 was established. Action Group 1 will be in charge of coordinating the In-Situ visits and exchange of experiences related to Thematic Area 1, as well as performing the Action 1 Report.
