

Findings: cases of similar sectoral distributions of staff numbers, 2010











Both increase: ending up with more firms and more people employed overall more competition, each firm produces more and needs more staff (basic theory) larger workforce who know/learn about the business— more firms











Both decrease: ending up with fewer firms and fewer people employed overall









Both move simultaneously: both increase or decrease together





Ending up with fewer firms (less competition) and more people employed overall











Both move simultaneously: both generally increase or decrease together (appear as if they are all over the place)



















Both decrease: less productive and profitable





Conclusions

We offer a broad view on business life and performance that complements the individual sectoral or subsectoral analyses on such matters usually carried out for single member-states or groups of member-states.

Despite operating in the same legal-competition-funding-export framework, on average, EU businesses exhibited differences from one member-state to another (within sectors) and from one sector to the other (in the same state).

If EU member-states move in different directions and/or with different speeds in key business development and performance aspects, EU policy interventions may have to carried out accordingly.

By identifying these differences we enable future research to:

- Look into the things that cause the differences, and
- draw useful lessons for businesses and for territorial and sectoral development policy.
