1. Definition of the upcoming steps

Peer review exercises under the guidance of Orkestra. Presentation of the peer-review

methodologies and insights from the baseline study and posterior discussion among partners.

The conclusion of this exercise was to launch an internal call with the aim of defining the peer reviews

(deadline mid June 2017). At the same time, the partners committed to hold their first meeting with

the stakeholders before the end of the first semester and to publish the press release regarding

MANUMIX and the first Learning Journey.

The partners also committed to develop a brief document explaining what they have seen interesting

during the first learning journey in the Basque Country. This exercise will help to identify the best

practices the project intends to find.

Second point of the day was the definition of the 2nd learning journey. The partners concluded that:

Next learning journey should be finalised in 2 days.

- Modification of the next learning journey date and location. Due to climate issues the
 partners took the decision to change the dates of the next meeting (Lithuania) for the
 meeting in Piedmont (Italy). The date will most probably be in November.
- Orkestra, as advisory partner, will support Piedmont region drafting the contents of the second learning journey.
- The previously established order of the learning pillars was also modified. Learning pillar 3 was going to be addressed during the third learning journey in Piedmont, therefore the modification of the LJ's date will trigger the modification of the learning pillar to be addressed. As a result, learning pillar 3 "Action oriented evaluation" will be held during the second LJ while learning pillar 2 "Monitoring" will be held during the third LJ.
- Commitment to reorganise the learning journeys scheduled in year 2018 as the dates of the two LJ were to close.
