Day 1 – 22nd February 2017

INTERREGIONAL EVENT

- Presentation of the Regional Innovation Ecosystem in Navarra (ADItech and Government of Navarra)

Silvia Ojer from Government of Navarra explained the current situation of the Navarra Region in innovation concernings, the content of the reviewed RIS3 in Navarra and which are the main lines and objectives of the new Science and Technology Plan.

- Strategies for Innovation through R&D Projects

1ST PEER REVIEW MEETING: Tractor Projects

- Presentation (ADItech)

35 questions were received for the Peer Review. These questions were grouped in 4 parts in order to answer all of them:

- PROPOSALS + ENTITIES INVOLVED
- 2. COLLABORATION AGREEMENTS
- 3. EVALUATION of the proposals
- 4. DEVELOPMENT of the projects. MONITORING

Each aspect was explained in details and several examples were also addressed.

Several comments and questions were made by partners and stakeholders were also answered and explained.
