Strategic lines

The European Directive 2014/94/EU, declares that the States have to improve the public charging point network in order to guarantee the access to an adeguate number of vehicles until 2020.

Il Italy the law 134/2012 and the «National Plan for the Charging Point Network of the electric vehicles» (PNIRE) defines the development strategic lines.

The Electric mobility plan for Rome is planned according to this strategic lines and to Urban Traffic Plan of the city.

Abstract

The plan defines a charging point need in the public areas. It supports the private investments in the sector, defining its rules.

The plan includes a technical and administrative regulation that schedule:

How to submit applications

- •The technical specifications of charging points
- •Road signs of the parking area

The structure of the plan is based on:

- •A high speed charging point network (50 kW) along the main roads
- •A set of medium power charging points (22 kW). The planning of this points is based on the traffic flow



The high power network




The high speed charging network will be realized in two rings:

- •GRA (Outer highway ring) to intercept the traffic flow to the center of the town and the main tangenzial flows
- •Aurelian walls(Inner ring), with a network for the inner traffic flows of the city

The distance between the two rings is about 9 km


Estimated charging point

• EV sold in 2017 is + 20% compared to 2016 sales

- EV sold in 2020 will be a market share of 2% (National plan evaluation)
- The need for charging points in 2020 will be 10% of the number of the circulating vehicles (PNIRE surveys)
- The estimate need is 700 charging points for the metropolitan area
- The mobility in the metropolitan area is strongly related to the city of Rome


PGTU zoning






