1. TRIS proposal sent to the Ministry for Innovation and Technology – Department of Business Development

→ IFKA was invited to be a Steering Committee member of an OECD financed project to prepare the Hungarian circular economy strategy & action plan started January 2021

2.1 EDIOP 4.1.4-19 call: circa 88,8 million euro – closed in December 2020

Aim: to increase energy efficiency - **using biomass** (just one element – no info yet how many companies applied for this subtopic)




Objectives:

It is always linked to a determined call! – 1st phase EDIOP 1.2.11-20



Structure of the form:

- Assessment of the company's current situation (50 point)
 - Basic data and general financial statistics
 - Past achievement
 - Strategic cooperations
 - Midterm strategic elements (employment policy, international markets)
 - Resource and energy efficient measures
- 2. Evaluation of the development concept (40 point)
- 3. Certifications /e.g.: ISO14001, 50001, EMAS, ecolabel (10 point)

Submission of applications to the Managing Authority

The certificate is a pre-condition for the submission!
