PREPARATION

What was your experience in arranging the Peer review? How was the reaction of the stakeholders? Did you receive any useful inputs from the Peer Review Team/experts during that preparation period?

Peer review preparation enabled to summarise the main existing problems, to define the questions and to mobilise the stakeholders in the region. The stakeholders were strongly interested, because number of activities are under development and under realisation in the moment and it was visible, that the direct communication and discussions with international experts were motivating for regional stakeholders, this was clear also during the non-official activities of the event.

IMPLEMENTATION OF THE PEER REVIEW

Key question – clarification of the role of the Region as an institution in enterprising support, i.e. the role of the Region in relation to firms and the state, which provides the financing and the organisation provision of the majority of supporting programmes.

Role of experts

Documents define number of measures, but the financial and "human" capacities for realisation are limited. The task of experts participating will be to help to answer the following questions:

(e) Recommendations: please list and explain the conclusions and main points of advice you received from the experts

Z.Hušek presented the summarisation of the results of the peer review by transnational experts. The main topics were stated:

1. The role of the Ústí Region in coordination of the SMEs support

Definition of main problems- administration barriers, necessity of "good working positions – better jobs" in the region.

These topics were commented by the transnational expert team — Mr. Giovanni Librici GIOVANNI LIBRICI (Program Manager PURE COSMOS Project and the head of the financial department of the Municipality of Genova, IT) informed on the situation in Genova, financial sources and their management, management of real estates in the City ownership, focus on ICT utilisation.

Mr. Hugo Russel (Birmingham, UK) presented the coordination of services in Birmingham, local and regional management and the work of the "Call center" monitoring the SMEs operating, the provision of the support to specific businesses, the system of SMEs support in Birmingham and support of the family business, management of funds for education and trainings.

2. Skilled work force

Expats – attracting and support of migrating technical work force is recommended.

3. Administrational barriers

Ms. Paola Dellepiane, (Manager - Responsible for Procedures at FI.L.S.E. SpA (Ligurian Finance Company for Economic Development) Genova, IT)), presented in detail the established regional (Liguria Region, IT) monitoring digital system, available to SME's to apply for funding, informing directly the applicants on mistakes in the application and providing them with the necessary documents, information on eligible costs, open calls. She clarified the advantages of the system as time saving, transparency for applicants, better informing.

Ms. Parthenopi Sourmaidou, (Managing Director, Ergani Center (ANATOLIKI S.A., GR)), mentioned the services provided for women in SMEś support and presented the activities provided in Thessaloniki and the impact of them on the women employment rate, environment, tourist services etc.) together with the specifics of women enterprising support.

- The findings of the discussion on regional one stop shop will be included in the strategy,
- Utilisation of expert's recommendations in searching the forms of coordination of activities and minimisation of twinning the activities
- Focus of the work on the Regional Innovation Centre ICUK on the ecosystem development instead the infrastructure
 - Monitoring of the best practices of partner s regions 'during study visits and other PURE COSMOS activities (focus on granting management system in Liguria, GrowthHub in Birmingham etc.)
