1)Title: THE BIG SWITCH OFF - behavioral change campaign

Focus: Relevant for all 4 topics, but especially for the implementation aspect

Points of relevance: this awareness campaign based on social marketing techniques, was structured in 2 weeks for each building, has involved workers in public offices and has achieved very good results, from a minimum of 8% to a maximum of 18% of electricity savings.

2) Title: SYSTEMSLINK WEB REPORTING SYSTEM

Focus: Relevant for all 4 topics, but especially for the monitoring

Points of relevance: The SystemsLink Web Reporting System is designed to help you monitor the consumption of electricity, gas and water at your premises and keep track of costs. It provides a clear set of reports showing utility consumptions and costs.
