1.3 Highlights of main achievements

During the 1st period, the partners participated in the KoM in Larissa on March 2018 & agreed to the internal SCM rules as well as the management & publicity obligations according to the program rules. The key points (incl. activities & del.) of WP1, WP2 & WP3 were clarified & the partners focused on the project objectives, results, outputs, target groups & future activities. The LP in collaboration with the MA & the project partners completed successfully all the procedures of the clean-up phase & signed project's partnership agreement & the subsidy contract.

The Partners elaborated & submitted on time their progress reports following the guidelines of the LP. Furthermore, most of the partners (excluding PP2, PP6 & PP7) inserted & validated their expenses in SYNERGIE.

Regarding the WP2, the structure & the methodology for the joint communication plan (Del 2.2.1) was designed by the LP and shared to the partners. Most of the partners provided their contribution for it. The final version will be ready on the 2nd semester. The social media pages (Del 2.2.2) & the project webpage (Del 2.4.1) are active & PP1 is feeding it with news and posts with the contribution of the partners. Furthermore, several partners had participated in Events of Interreg MED programme such as these in Rome in April in the context of del. 2.3.2. Regarding the WP3, the LP designed the template and the methodology of del 3.1.1 & 3.1.2 & PP1 did the same for del.3.1.3 & 3.1.4. Most partners worked on these 4 deliverables

in order to finalise them in the 2nd semester. Lastly, the methodology and guidelines for the Del 3.2.5 were given by the LP to the partners and in this context 2 consultations were organized by PP3 and PP4.

Specific Objectives

Partners have successfully co-operated together in project's Del. 3.1.4 & 3.2.5, in order to "Improve the existing innovation framework conditions on the MED agricultural sector" SO.1. & in Del. 3.1.3 & 3.2.5 in order to "Increase the number of enterprises receiving grants for eco-innovation related to greenhouse production" SO.3.

Main Outputs

The main outputs of the project are still in progress. 3 out of 4 tools are expected to be produced on the 2nd semester. Cooperation Added Value

The joint character of project activities & effective cooperation of partners, as well as their active role in the project and participation in numerous events, provides the project with a pool of experiences/know-how/ideas/proposals at transnational level.

1.4 Problems and solutions found

No major issues have occurred during the 1st period. However, some minor "matters" are:

Implementation activities

1. The joint Communication Plan (Del. 2.1.1) will be elaborated in the 2nd Semester by the external expert of the LP by taking into account the contribution of the partners. The deliverable could not be finalized in the 1st Semester due to delays in the launching procedures of the Public Procurement of the LP. However, the tender had already been launched and the selection of the external expert will be announced in December 2018.

Administrative & financial management

1. PP7 could not attend to the KoM due to logistic & administrative issues with the supervision body (Ministry of Agriculture). However, they were fully aware of the decisions taken and agreed on them while they received the presentations and the minutes of the KoM.

2. PP6 could not open a bank account due to bureaucratic procedures of the Ministry of Finance (Supervision body). However, they got the Green light and this is expected to be opened in November.

3. LP, PP2, PP6 and PP7 had some delays in the selection of the External Expert due to bureaucratic procedures and delays in the launching of the Public Procurement. However, the Tenders of LP, PP2 and PP6 had been launched in November and the selection of the contractor is expected to be announced in December 2018. The launch of the Tender for the selection of the External Expert of PP7 is expected in December 2018 and the Selection of the contractor will be announced at the beginning of January 2019.

The above are not hindering the overall very good flow of the project, but are continuously being monitored by the LP, who is also in constant interaction with all involved parties (PPs, JS, FLC etc.) towards overcoming such issues.
