## Report on Local Working Table - Year 1

Date: 28.02.2021

### Number and categories of participants / target groups

6 participants (Higher education and research - Institute of Theoretical and Applied Mechanics, Local public authority - Municipality Prague Troja)

### Topics tackled & links to deliverables/outputs

#### D.T1.1.2, D.T2.1.1, D.T2.1.2

The project aims and development so far has been presented, as well as the capitalised project. After that the deliverables above, for which the PP2 is responsible, were briefly introduced. A possibility of enlarging the pilot site Troja hamlet by nearby Stromovka (a historical park across the Vltava river, endangered by floods, instable soil, biotic agents etc., managed by the City of Prague) was discussed, as for the use of the webGIS tool the Troja hamlet area is rather small for it to be comparable with other pilot cases. Also discussed was how the pilot site will be assessed - as a whole area or each monument separately in more detail. Pros and cons were mentioned. Related to that is the strategy from D.T2.1.2. Municipality Troja representative mentioned that for the managers of the specific cultural heritage sites, it would be more practical to have their own specific strategy. He was also introduced to the vulnerability assessment index and gave his feedback on it (especially regarding the approach of the local CH managers and their introduction to it as the success of the strategies depends upon it). In the end, R. Cacciotti (PP2) summarized the challenges in the future work on the project (complex sites with multiple objects, concept of multi-risk and their synergies, standardisation of the results - how to make them comprehensible while not misleading). A recording of the LWT1 has been made (participants agreed) for possible future use.

### Expected effects and follow-up

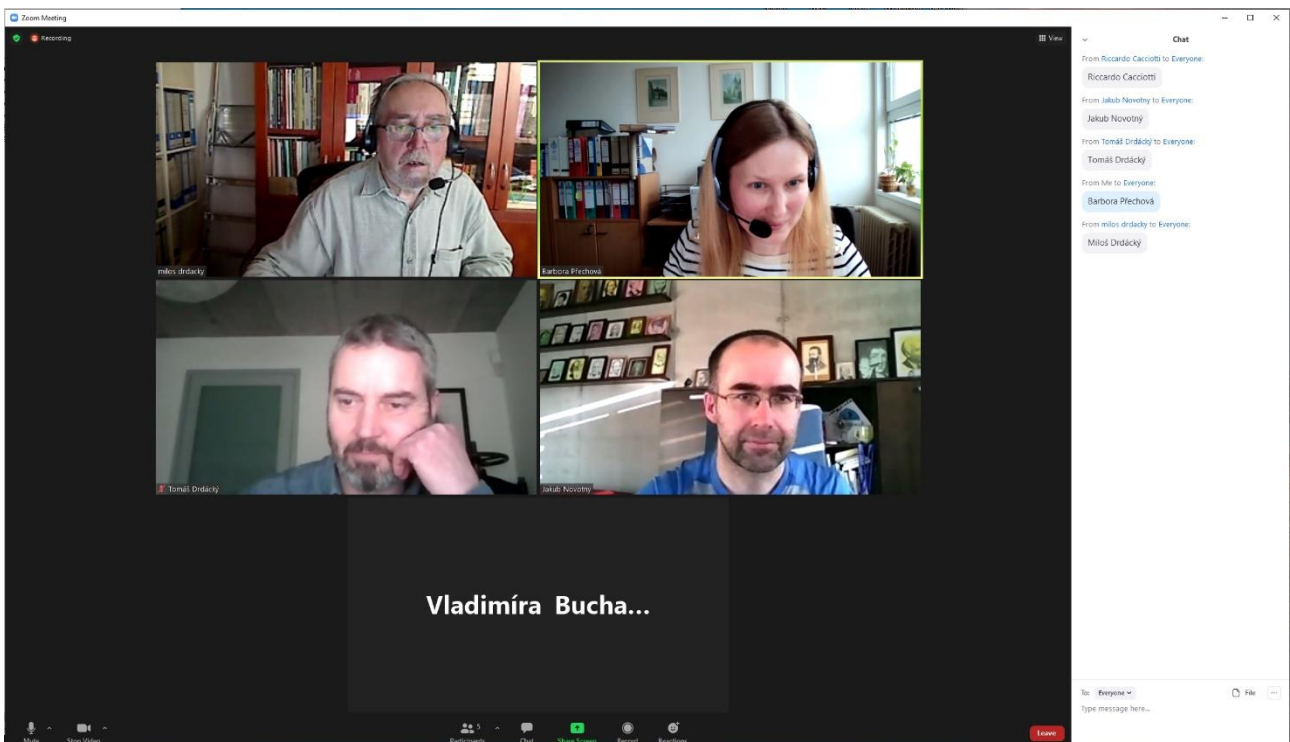
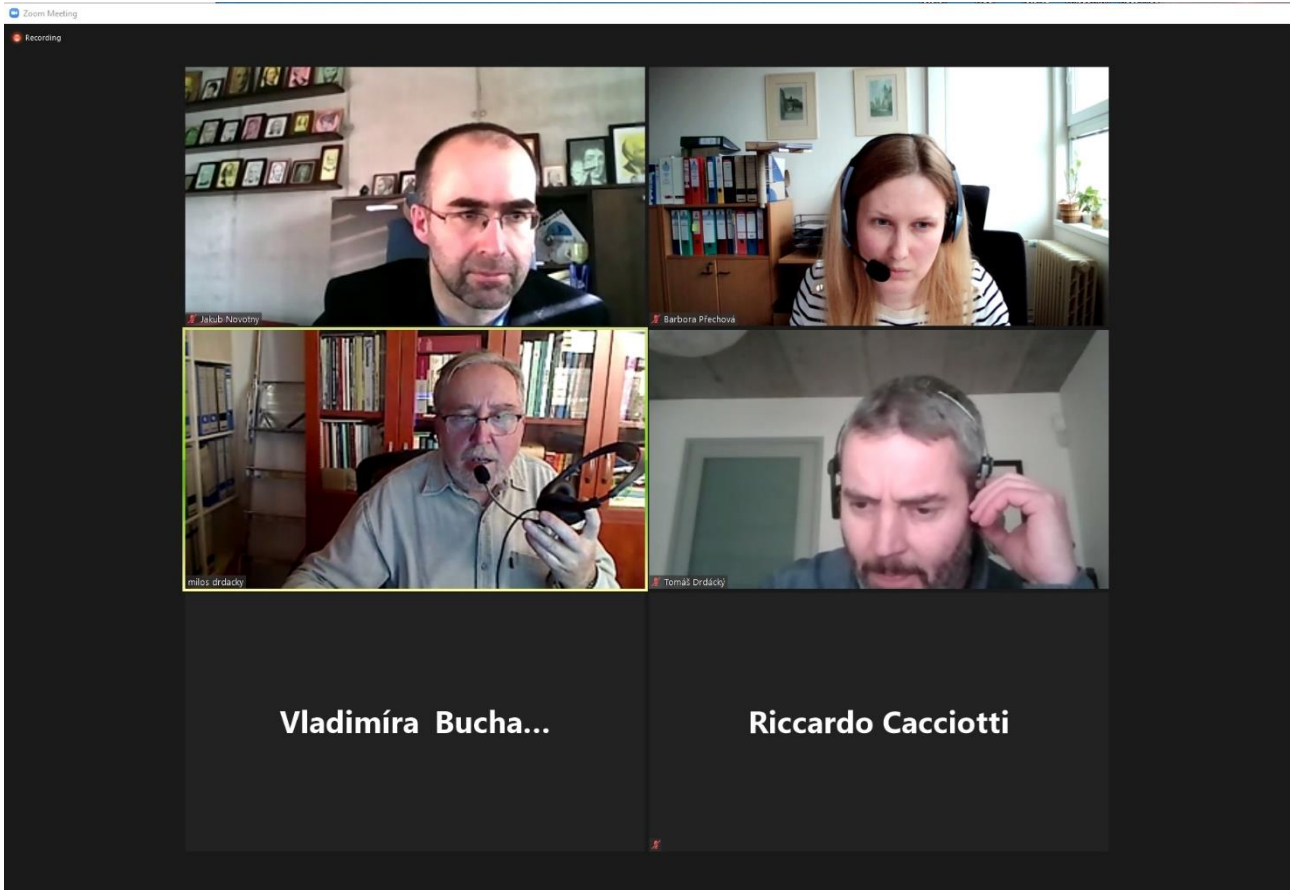
Expected effects are better coordination with the Local public authority at the pilot site, cooperation with local managers of endangered sites (not only Troja Chateau) through Municipality Prague Troja. Possible enlarging the pilot site by Stromovka historical park. It was also discussed what further experts on natural hazards could be involved. Feedback on the deliverables (especially the vulnerability ranking) has been given. The PPT presentations will be made available to all the participants for further dissemination.
