Topics tackled & links to deliverables/outputs

The Urban Planning Institute of the Republic of Slovenia (UIRS) hosted the second STRENCH Local Working Table (LWT2) online on November 17th, 2021. The meeting was organized in a small group of people actively involved in engaging stakeholders.

The meeting dealt with the impacts of extreme events on cultural heritage in Vipava Valley. The first theme was discussing the climate-related hazards for cultural heritage that stakeholders in the Vipava Valley are facing. The second theme was about the actions taken by Vipava Valley municipalities to tackle the problems. These discussions were connected with two deliverables:





the vulnerability evaluation for Vipava Valley as part of the deliverable D.T1.2.2 Definition of a methodology for the ranking vulnerability of cultural heritage and Deliverable D.T2.1.2 Sustainable risk management strategies for CH protection.

At the meeting, UIRS also draw attention to the WebGIS tool and presented deliverable D.T1.3.3 Tutorial development for user-friendly transfer of the WebGIS tool.

The final part of the meeting was the planning and organizing the awareness raising event for fostering transnational cooperation in disaster risk reduction (D.T2.3.1). It was decided on the date, format, and invited stakeholders and content.
