# Project BLUE\_BOOST Innovation Voucher Scheme

The BLUE\_BOOST transnational innovation voucher scheme is composed by a unique transnational call for projects proposals to be granted with innovation vouchers (max 10.000,00 euro), launched in all the 7 project's Pilot Areas.

Around 350.000,00 euro, for 35 vouchers, 5 (in most cases) per partner area, have been allocated to MSMEs & START-UPs wishing to improve their position all along the value chains of Blue Economy.

## Involved parties of the Scheme



- a) INNOVATION VOUCHER DONORS: project partners (PPs)
- b) INNOVATION VOUCHER SCHEME EVALUATORS:

PPs and Associated Partners.

c) BENEFICIARIES: MSMEs and / or Start -Ups of traditional mature blue growth sectors such as fisheries, logistics, shipbuilding/repair and of the new emerging market niches such as blue technology (including aquaculture and biotechnology), robotics, new materials, green shipbuilding, monitoring of the sea, deep sea resources, bio security which have their and headquarters/branch office in each project partner region, active in one of the Blue sectors selected by the PP (3 for most PPs).

## Involved parties of the Scheme

#### d) KNOWLEDGE PROVIDERS:

Research, Development and Innovation Bodies, skilled enterprises specialised in marine/maritime sciences, technologies and business management, and open source – knowledge sharing and community based non-institutional New Innovation Agents such as fablabs, co-working spaces, innovation hubs, living labs etc from the whole ADRION Program eligible Area, acting as knowledge providers.

### Methodology



Thessaloniki Chamber of Commerce and Industry (TCCI) valorised experience from past EU projects and initiatives, as well as information gained through project's regional Blue Growth studies, to elaborate a specific methodology for the implementation of the BLUE\_BOOST pilot action.

The methodology was tailored to specific local innovation needs of detected Adriaticlonian Blue sectors.

It is a document containing the BLUE\_BOOST common vision and detailed workplan, which describes all the implementation stages of the pilot action.

### **Coaching Path**

A 3-stage Coaching Path was foreseen and implemented in every Pilot Area: BLUE LABS, BLUE SCENARIO WORKSHOPS and BLUE HACKATHONS offered local SMEs information and competences on innovation development.

Most important, they offered excellent networking opportunities among people involved in the Regional Blue Growth community, mainly among businesses and potential Knowledge Providers.

This networking played a decisive role for developing innovative projects proposals for BLUE\_BOOST Innovation Vouchers.

# Attraction of Knowledge Providers



A transnational call for Expression of Interest of Knowledge Providers (B B KPs EoI) was composed by TCCI and launched by PPs in February 2019, in all the ADRION eligible territories, in order to develop a database with all possible relevant knowledge / technology providers to be chosen by the vouchers applicants (Blue sectors MSMEs/STARTUPs of involved territories). Finally, the Call for Eol was opened in June 2019 even to KPs not based in, but being able to provide services in ADRION area (in EU more generally).

No sectoral or expertise restrictions were foreseen regarding the profile of KPs.

### Knowledge Providers Gallery

An on-line KPs Gallery was created, containing Research, Development and Innovation Bodies, skilled enterprises and New Innovation Agents (fablabs, co-working spaces, innovation hubs etc) eligible as B\_B KPs.

The Blue MSMEs/STARTUPs wishing to participate in the B\_B Innovation Voucher Call had to choose a KP from the Gallery.


The B\_B KPs Gallery is still available at the BLUE\_BOOST Networking Platform, on <a href="https://blueboost.unicam.it/">https://blueboost.unicam.it/</a> and is still open to new entries, until the end of the project.

It is intended to be treasured and capitalized by partners and stakeholders beyond the B\_B lifetime in other initiatives aimed at improving Blue Growth innovation and knowledge in the Adriatic-Ionian area.

# Call for Innovative Projects Proposals



BLUE\_BOOST transnational Call for innovation vouchers was launched in May 2019 and promoted in all the 7 ADRION areas to realise innovative projects Blue MSMEs/STARTUPs in collaboration with KPs. Each pilot area had €50.000 for allocating to at least 5 vouchers.

The Call included Terms of Reference and all necessary documents, for the businesses, Knowledge Providers and PPs, in a complete Application Package provided by TCCI.

PPs and their Local Innovation Committees (LIC) supported businesses and their KPs, in order to develop innovative project proposals, among others also by organising Info Days.

# Transnational Brokerage Event



To enhance transnational networking of MSMEs - START-Ups & KPs a transnational brokerage event was held in Thessaloniki, on 5<sup>th</sup> June 2019, organised by TCCI.

In total more than 70 participants, stakeholders were selected by their local PPs, following a public Expression of Interest.

More than 40 brokerage meetings were realised between interested parties.

Apart from the networking of SMEs with KPs, in vue of the Innovation Vouchers Call, the Brokerage Event aimed more generally at promoting cooperation, for example between Blue MSMEs & START-Ups or between KPs from different BLUE\_BOOST Regions.

# Reception of innovative projects proposals

The B\_B Innovation Voucher Call closed in July 2019.

In total 57 proposals of innovative projects were received by the 7 PP:

56/57 proposals were formally eligible, proving the effective support provided to candidates by PPs.

# Evaluation of innovative projects



Applications, including all stages of the innovation cycle, at technical, organisational and marketing level, were selected locally, by LIC of each PP, according to the same transnational criteria, included in the Call:

- > Excellence (40%)
- ➤ Impact (30%)
- ➤ Capability (30%)

Each PP granted its area's best selected projects, according to their budget, within the limits of its budget (50.000,00€ each) and kept the rest eligible ones in reserve list.

## Selection and contracting


Selection and contracting was realised by the end of August 2019, despite the fact that the necessary stage of De Minimis eligibility control had to be realised centrally, by the ADRION JS.

The projects granted by Pilot Area were:

BLUE\_BOOST reached the target of granting 35 Innovation Vouchers.

# Implementation and monitoring



Awarded MSMEs/STARTUPs and their KPs had at least 6 months to conclude the agreed activities, according to their Application Form.

Monitoring visits were held by local PPs guided by their LICs, at the beginning of the implementation period.

After that, LICs drafted a Startup Report highlighting positive project workflow and / or possible problems such as unjustified delays, unexpected conflicts between MSMEs & KPs etc.

If a Startup Report identified severe problems in the implementation of a project, the Pilot Partner could withdraw the voucher and award the 1<sup>st</sup> of the reserve list.

## Completion of projects

Upon the conclusion of each innovative project, a Final Report describing the activities implemented in its framework was composed by the relevant KP and delivered to the MSME/Start-up.

All the beneficiary MSMEs/Start-ups approved the Final Reports and forwarded to their competent PP respective Requests for Payment.

Responsible Pilot Project Partners validated each project's Final Report within 15 working days from the date of submission and accepted the Request for Payment or requested integrations, additional information, documents etc.

## Payment of Vouchers



Apart from a few cases where specific circumstances, mainly the COVID-19 situation, provoked delays to the projects' completion, all other projects were validated within foreseen time frame.

Payment procedures were delayed by COVID-19, due to quarantines, but:

29 / 35 B\_B Innovation Vouchers were paid out by June 2020.

34 / 35 have been paid out by beginning of October 2020.


In one case, Social Security procedures have not allowed payment, expected soon.





# Evaluation of Voucher Scheme

The external evaluation regards the whole pilot action rather than individual projects, in particular output additionality and behavioral additionality: if or not the assignment for which the voucher was given would have been carried out also without the funding support and if or not the SMEs have further contracted other KPs for follow-up assignments paid through other means.

This activity is also used to identify success stories for dissemination and lines of development for following or transferable schemes.

BLUE\_BOOST Associate Partners are involved in this activity, supporting PPs.

### BLUE\_BOOST Networking Strategy



BLUE\_BOOST also includes a complete Transnational Innovation Networking Strategy and relative Joint Action Plan, to create and animate an informal network composed of INNOVATION KEY ACTORS of the ADRION maritime clusters, aimed at promoting new forms of trans-boundary cooperation across maritime sub-sectors, favour new value chains of products / services, supporting benchmarking and learning through the open source, knowledge sharing and community based approach promoted by B\_B.

B\_B Network will be an important asset to be valorised even after the project lifetime.
