BACKGROUND

In developing the Transnational (European) Blueprint it is of key importance to keep in mind the EU context within which the five year plan is to be developed. To that end, in our analysis we:

- note that the regulation and focus on migrant entrepreneurship specifically dates from around 2016, as a reaction to the large migrant wave that occured in the EU
- we emphasise the newer regulation/strategy 2020/2021 that has to do with entrepreneurship but is more focused (of course) on recovery, digital etc as is the new EU Strategy (s) reflecting the current crises (Pandemic)
- another important aspect of the European context and in dealing with the
 needs of migrant entrepreneurs is the way to reduce and simplify the
 regulative and administrative burden as well as steps towards standardisation
 that can aid foreigners in doing business in new countries.
- note there are interesting initiatives like the transfer of business initiative
 which might aid migrants looking to start a new business in a new country
- there are process that can aid with the important aspect of the Transnational blueprint such as entrepreneurship education European framework
- there are possibilities of financing entrepreneurship, and we included two such mechanisms as well as a small infographics - COSME and Access to finance in this document







