The main objective of the INTENT project is to use guidelines and benchmarking to trigger social entrepreneurship solutions towards better patient-centred cancer care in Central Europe. In order to achieve this goal, in each participating pilot site a stakeholder panel is set up to contribute to the following tasks and activities related to the development and implementation of a patient centered model of care:

- Co-produce a patient-centred cancer care model and guidelines by filling out the relevant surveys developed by the WP T1 leader National Cancer Institute IRCCS CRO Aviano.
- Participate in setting up the pilot benchmarking exercises.
- Take part in testing the benchmarking indicators.
- Prepare performance improvement plans and change management action plans based on the outcomes of the bencmarking exercise.
- Implement the local project communication roadmap together with the WP C communication team.
