#### Short Description / Summary

Due to the very bad situation in the Czech Republic regarding the Corona virus pandemic, we could not organize open "normal" workshop. We tried to organize on-line meeting but since March almost everything was organized on-line, the people are almost fed up with on-line meetings.

Finally, we organized it together with company UDIMO who prepared our SUMP. Mr. Kuchta was presented as the representative of municipality of Hranice, Mrs. M. Skrobankova as the project manager and Danuše Strnadová as the Expert (project member).

The goal of this meeting was again explaining the complex process of SUMP preparation which was interrupted by pandemic of corona virus. The original plan was to finish SUMP in the summer and introduce complete plan and next steps for the future. As all the processes were delayed the main discussion was about:

- Proposals for modification of non-motorized transport
- Classification of the communication network of individual automobile transport
- Proposals for modifications of the public transport network
