## 1. INTRODUCTION

### 1.1 Scope and objective of the deliverable

The present report is developed to evaluate GRASPINNO's Unified Platform by Public Authorities (PAs) and SMEs that used it for the purposes of the pilot of the Department of Public Works. More specifically, the target group of this evaluation was the Department of Public Works, the Energy Department, the Cyprus Energy Agency and the SMEs that got involved in the pilot or showed interest in adding their products in the platform. Two questionnaires were delivered by the LP (one for the PAs and one for SMEs) to be answered by the users and analysed by the partners. For the reason that only those who got involved in the pilot answered the questionnaires, the studied sample is limited.

### 1.2 Structure of the deliverable

In Chapter 2 of these deliverable, the analysis of the answered questionnaires is presented, through tables, charts and percentages.

In Chapter 3, the final conclusions and proposals for improving the Unified Platform are being summarized.

## 2. QUESTIONNAIRES ANALYSIS

The questionnaires were delivered to the involved people in Public Authorities and SMEs by the Department of Public Works, in a word format through email and returned back with the same way. In total, 11 questionnaires were collected (7 from PAs and 4 from SMEs).

1 evaluator didn't answer at all in this section, while 1 other answered negatively and all the others (5) positively. This means that a $71,4 \%$ of the users found it easy to make calculations of the LCC by using GRASPINNO's tool.

The same as above. $71,4 \%$ found easily all the appropriate parameters for calculating the LCC.

The same as above.

1 evaluator didn't answer at all in this section, while all the others (6) responded positively. This means that a $85,7 \%$ of the users found it easy to recover from their mistakes.

## 3. CONCLUSIONS

In general, the GRASPINNO Unified Platform was positively commented and the overall satisfaction was high. There was only one negative comment due to the lack of faith in Public Authorities to use this tool that had nothing to do with the tool itself. This shows that PAs should motivate more people to register in the platform and show their commitment in Green Public Procurements in general. Furthermore, it is generally believed that with minor amendments and additions the tool will be very user friendly and its use could be extended.

### 3.1 Proposals for improvement

After the evaluation from the users (both Pas and SMEs), the main proposals for improving the GRASPINNO Unified Platform are as follows:

- More products should be added and they should be more clearly and extendedly categorized. Images per category could be useful.
- More SMEs should be registered and add their products.
- There should be a criterion for the registered SMEs: 'Green Standard Criterion'.
- Graphics should be improved and logos and images of the products should be added in the tool.
- Translations to other languages (especially for the downloaded TIPs) would attract more users
- Identification of key aspects (i.a energy indicators)
- PDF of product could be very useful if it was available for download
