REgenerating mixed-use MED urban communities congested by traffic through Innovative low carbon mobility sOlutions

The project aims at fostering the use of available low carbon transport systems and solutions through the testing of an operational path in the governance and management of high congested roads, a common issue for many middle-sized Mediterranean cities lacking of proper orbital roads or bypasses.

The Participatory Approach under REMEDIO Project

HORIZONTAL CONDOMINIUM of the West Road in Treviso

REMEDIO is testing in 4 pilot cities a participative approach that proposes to transform high congested roads of middle size urban areas in "horizontal condominium".

The "horizontal condominium" is proposed as an effective way to engage trade and business operators, enterprises, commuters, citizens, local communities and obviously local authorities in sharing a new vision for these high congested roads surrounding the city centres.

Thanks to REMEDIO project and the MED funds, the initiative is now widening its area of intervention towards the Sustainable Mobility profile of the axis, that is a mixed-use peripheral road of the middle sized city center of Treviso.

The leverage to engage trade and business operators and enterprise might be in term of incentives for energy saving and the promotion of renewable energy sources or for actions promoting a more sustainable mobility profile of the area or in the housing renewal and building refurbishment.



In Treviso The "*horizontal condominium*" has been already established, thanks to the submission of a

among the three main authorities that will be later work on enlarging the initiatives to other strategic stakeholders that might join this vision of a unique "horizontal condominium", more liveable and with better mobility, environmental and health conditions.
