Summary description of the strategy/action plan (developed and/or implemented)





Through the consolidation of regional and national strategy in the area of Smart Engineering and Rapid Prototyping ("SE/RP") into one transnational roadmap for SE/RP which focuses on content-related Knowledge Axes, organizations in Central Europe will be able to develop a much clearer perspective on the market opportunities (and associated market challenges) that exist within and external to the participating regions. Roadmap is a specialized type of strategic plan that outlines activities an organization or group of organizations will undertake over a specified timeframe to achieve stated goals and outcomes. Roadmapping will be the evolving process by which a roadmap was created and implemented, while in later phase it will be monitored and updated, if necessary.

Roadmap with its action plans is providing the future development process of each KACE topic until end of the project and near future. On action plan level each KACE topic is divided into subtopics, where different cooperation actions are identified in order to prepare for further activities within the project. Additionally it also helps Associated partners and external stakeholders to identify opportunities for the future. Cooperation actions are including R&D projects, trainings and strategic actions, which are defined by partners within the timeline of the project or beyond its implementation.

These action plans are representing the solid ground for activities in WP2 and WP3, where R&D projects will represent the basis for capitalization, trainings will represent the content for Moodle platform and strategic actions are thematic objectives for workshops with stakeholders.

Expected impact and benefits of the strategy/action plan for the concerned territories and target groups





Impacts and benefits of the roadmap with action plan is following:

- Regional and national authorities are able to view concrete strategic actions, which are needed in order to further develop different thematic areas, which are normally formed within the smart specialization strategies
- Higher Education and Research organization are able to see training curricula or thematic areas, which should of interest for their educational program. Additionally, they can observe in which R&D projects they could cooperate with SMEs or Large enterprises.
- SMEs and Large enterprises can join the training contents of the different thematic areas and they can join the initiative of common cooperation projects.
- Business support organization (Technology Parks, Chamber of commerce, clusters...) can learn about thematic areas and support their members with technology transfer within identified topics.

Sustainability of the developed or implemented strategy/action plan and its transferability to other territories and stakeholders

Roadmap with action plan is representing the basis for activities within WP2 and WP3, where stakeholder workshops will be organized to further discuss the roadmap and associated action plans, and gain feedback on relevance across Central Europe's regional and national ministries.

The Roadmap takes the regional RIS3 topics of the involved regions into concern and will already fit to the regional strategies in a wide range. The action plan can easily be transferred to any territories and stakeholders, as it is based on MS-Excel document and has a clear structure. Further on Action plans are developed to be used as working-paper to be permanently updated and used as instrument in WP3 also. The KACE topics and subtopics are applicable in most European territories/regions, which means to be good basis for transfer.

Lessons learned from the development/implementation process of the strategy/action plan and added value of transnational cooperation





Lessons learned from the development/implementation process are connected to common approach of all partners, which was divided into phases, from planning to creating a vision, which was followed by development process.
